2020 dated 13th April, 2020, 33/2020 dated 28th September, 2020 and 39/2020 dated 31st December, 2020 ('MCA Circulars') and pursuant to Rule 20 and 22(3) of the Companies (Management and Administration) Rules, 2014, the Company issued a public notice by way of advertisement published on 6th January, 2021 in all editions of 'Financial Express' (English Newspaper) and in 'Jansatta' (Hindi Newspaper) giving intimation to its Members that the Postal Ballot Notice containing the resolutions to be passed through postal ballot / e-voting has been sent only through electronic mode to all the Members of the Company who have registered their e-mail IDs with the Company or with Depositories / Depository Participants and the manner of registration of e-mail IDs by the Members (both physical and demat) who are yet to register their e-mail IDs with the Company and regarding completion of dispatch of Postal Ballot Notice by e-mail and containing all the matters as required under the Companies Act, 2013 and relevant rules framed thereunder.
